The Arkansas Supreme Court Library, created by Act of 1851, serves the justices and staff of the Arkansas Supreme Court, the judges and staff of the Arkansas Court of Appeals, and support staff located within the Justice Building, 625 Marshall Street, Little Rock, Arkansas 72201. The library is open to the general public, from 8AM-5PM, Monday-Friday (closed state holidays).

The library participates as a selective depository in the federal government document program; and the Arkansas state government depository program. Public computer terminals are provided for Internet access, including subscription databases WESTLAW, LOISLAW CONNECT, The Making of Modern Law, and HeinOnline. Free Wi-Fi access is provided. Library materials must be used on-site, and may not be checked out.

There is no fee to use the library. A charge is made for photocopies.
