The Arkansas Supreme Court Communications Counsel serves as a media liaison for Arkansas's Judiciary. I can help members of the press with background, legal terms, identifying on-the-record sources, explanations of rulings, FOIA requests, and other legal issues being covered by the media. As an attorney working for the judiciary, I cannot offer opinion, interpretations or legal advice, but I will do my best to help you find those who can. Both judges and practicing attorneys are bound by ethical rules regarding public dissemination of information. [Please see Code of Judicial Conduct 2.10 [3] and Rules of Professional Conduct 3.6 [4]].

In addition to being a media contact, the communications counsel's role is to help improve access to the courts, educate the public about the judiciary's role, court rules and procedures, court-administered programs, and issues impacting the courts. Examples of programs available to the public include:

- Alternative Dispute Resolution [5] (Mediation)
- Court Interpreters [6] (includes many languages, from Hmong to Spanish to Sign Language)
- Court-Appointed Special Advocates [7] (for children)
- Arkansas Court Automation Project [8] (statewide case management for all courts)
- Drug Courts [9] (includes rehabilitation and social and professional development)

- Juvenile Division ^[10] (attorney ad litem, CASA, parent-counsel).
