



Are You CourtConnected?

CourtConnect has become an integral component of the Arkansas judiciary. Criminal justice agencies, law enforcement, and the public now rely on CourtConnect to contain timely, accurate and complete court information. This session explains the different versions and presents the latest modifications and how they will improve connections to your court.



Administrative Order 19



Section V.A. Courts should endeavor to make at least the following information, when available in electronic form, remotely accessible to the public:

- (1) litigant/party/attorney indexes to cases filed with the court;
- (2) listings of case filings, including the names of the parties;
- (3) the register of actions or docket sheets;
- (4) calendars or dockets of court proceedings, including case numbers and captions, date and time of hearings, and location of hearings;
- (5) judgments, orders, or decrees.

Administrative Order 19


Section V.B. Remote access to information beyond this list is left to the discretion of the court as follows:

- (1) In the district courts, the district judges(s) shall decide whether to allow public remote access;
- (2) In the circuit courts, the Administrative Judge of the Judicial Circuit, with input from the Clerk, and, if applicable, the Ex Officio Circuit Clerk for the Probate Division, of the counties within the circuit, shall decide whether to allow public remote access;
- (3) In the appellate courts, the Supreme Court shall decide whether to allow public remote access.

Administrative Order 21

Section 2 (m) Public access terminal.

A “public access terminal” is a computer terminal provided by a clerk for viewing publicly accessible electronic documents. Public access terminals must be available during the clerk’s normal business hours and must include access to a printer.





Courthouse CourtConnect (CCC)

- Generally the same as **PCC**
- Each court will have a KIOSK user assigned with Level 2 security for information your court has determined may only be accessed **INSIDE** the court
- Kiosk user id = CCC[Court][Location] – e.g. CCC60CI, CCC26HT
- At “go-live” AOC will send passwords to courts
- Introduction of **CCC** allows enhancements to **ICC!**

New Features in ICC

- Add a log out button to all screens in
- Remove the “Not an Official Document” watermark
- Person search changed to require either last name **or** Driver License number
- Add options to view **criminal history** from Person and Event search screens




