Re: Drug Court Treatment funds

Dear Governor Beebe:

On behalf of the Circuit Court Judges that sit on the specialized dockets for the Arkansas Drug Court Program, and as chair of the Drug Court Judges Committee of the Arkansas Judicial Council, I am writing to request your assistance in the current crisis affecting the courts.

During the 2007 Legislative Session, the Drug Court Judges were successful in securing an appropriation of \$3 million per annum to be used exclusively by the drug courts for treatment of drug court participants. When agencies got their final funding levels, this amount was reduced in the Department of Community Corrections' budget to \$2,853,000.

During the 2008 spring conference of drug court judges, DCC approached the judges and requested an agreement to accept only the first half of the funding for FY 2008 (\$1.5 million) to help DCC address the necessary cuts you were requesting of approximately 7% across the board. We were assured that DCC would work to get the funding fully restored in January after state revenues might stabilize. This has not materialized.

In our emergency meeting on February 13, 2009, in an effort to be good fiscal stewards, the judges voted to place a moratorium on future treatment expenditures since it appeared that funding would soon run out. Because the providers have been willing to continue current patients in treatment, to my knowledge, no drug court participants have been kicked out of a treatment program. However, most drug courts meet once a week. Without access to treatment funding, we will likely soon have to suspend our programs until next July.

I know I do not have to express the success of the drug court programs to you since you have been a huge supporter of the program since its onset in the early 1990s. However, we are truly in a situation where we need your assistance by restoring funding to this

critical program for its continued success. Since 2007, we have expanded the number of drug court programs to 41 and are serving approximately 250 more participants annually. For every participant being served in the drug court program, we are saving the state of Arkansas thousands of dollars in continued criminal activity and incarceration costs. Drug and alcohol addiction is an illness. Without access to treatment dollars, the drug court programs are left with only a hollow promise to these participants. Following my signature is the complete listing of all the sitting drug court judges in our state.
