FINDINGS AND ORDER

The formal charges of misconduct upon which this Findings and Order is based arose from information

provided to the Committee by the Arkansas Supreme Court on September 9, 2004. The information related to

the representation of Andre L. Crawford by Mr. Newcomb in 2003 and 2004.

Robert A. Newcomb, Attorney at Law, Little Rock, Arkansas, represented Andre Lamont Crawford in

Phillips County Circuit Court. A Judgment and Commitment Order was entered in the Phillips County Circuit

Clerk's office on December 15, 2003 and a timely Notice of Appeal was filed on January 8, 2004. The record of

the proceedings in Phillips County Circuit Court were not filed with the Arkansas Supreme Court by April 7,

2004. The record was tendered to the Arkansas Supreme Court Clerk on July 9, 2004, but was refused as

untimely. On July 15, 2004, Mr. Newcomb filed a Motion for Rule on the Clerk. The Arkansas Supreme Court

granted the motion on September 9, 2004, and referred the matter to the Office of Professional Conduct.

Mr. Newcomb filed a response to the formal complaint and stated that there were extenuat

circumstances. On March 26, 2004, Mr. Newcomb filed a motion for enlargement of time after being notified

that the court reporter was unable to prepare a transcript. On March 24, 2004, twelve (12) days prior to the

expiration of the time to lodge the record with the Arkansas Supreme Court, an Order was faxed to Circuit

Court Judge L.T. Simes. The Order was signed on April 7, 2004, but not filed with the Phillips County Circuit

Clerk until April 14, 2004. Mr. Newcomb acknowledged the Arkansas Supreme Court's position that it is

always the responsibility of counsel to have appeals lodged in a timely fashion but denied that there was a

violation of the Model Rules.

Upon consideration of the formal complaint and attached exhibit materials, the response to it, and other matters before it, and the Arkansas Model Rules of Professional Conduct, Panel B of the Arkansas Supreme Court Committee on Professional Conduct finds:

1. That Robert A. Newcomb violated Model Rule 1.3 when he failed to undertake the necessary steps to

obtain a timely Order extending the time to file the record on appeal beyond the initial ninety (90) day limit of

the Rules of the Supreme Court and when he failed to file in a timely manner, the record of the proceedings in

Phillips County Circuit Court with the Arkansas Supreme Court Clerk. Model Rule 1.3 requires that a lawyer

act with reasonable diligence and promptness in representing a client.

2. That Robert A. Newcomb violated Model Rule 8.4(d) when his failure to file the record in a timely

manner with the Arkansas Supreme Court Clerk resulted in a delay in the orderly and timely resolution of

appellate proceedings and required the Court to expend additional time and effort which would not have been

necessary otherwise. Model Rule 8.4(d) requires that a lawyer not engage in conduct that is prejudicial to the

administration of justice.

WHEREFORE, it is the decision and order of the Arkansas Supreme Court Committee on Professional

Conduct, acting through its authorized Panel B, that ROBERT A. NEWCOMB, Arkansas Bar ID No. 73087,

be, and hereby is, CAUTIONED; fined the sum of FIVE HUNDRED (\$500.00); and assessed costs in the

amount of FIFTY DOLLARS (\$50.00) for his conduct in this matter. The fine and costs assessed herein shall

be payable by cashier's check or money order payable to the "Clerk, Arkansas Supreme Court" delivered to the

Office of Professional Conduct within thirty (30) days of the date this Findings and Order is filed of record

with the Clerk of the Arkansas Supreme Court.
