**Instructions:**

The adjudication/disposition form shall be completed and submitted by the attorney filing the initial pleading or other appropriate official as designated by the trial court. This form shall be filed with the court clerk.

1. Complete the docket number.
2. Fill in the name of the juvenile's attorney ad litem as well as any parent attorneys, and whether the parent attorneys were privately retained or appointed by the court.
3. Provide the dates of the adjudication and disposition hearings.
4. For each juvenile on the case:
  - a. Provide the first name, last name, and middle name or initial.
  - b. Select the trial type. It is a bench trial if evidence is introduced, regardless of whether a judgment is reached.
  - c. Select a single manner of disposition. Select transferred only if the transfer was to another judicial district (not within a judicial district).
  - d. Choose a placement outcome.
  - e. If there are more than two children on the case, attach an additional form.
5. Choose "yes" as set for review if the will have additional hearings on the case. "No" indicates that the case is legally closed and no further court action is anticipated.
6. Indicate whether an interpreter was used for the case. If so, for whom and what language was required?
7. Indicate whether a party to the case was pro se (not represented by legal counsel) for the adjudication/disposition portion of this case.
8. Public Law 104-193 requires collection of certain information in cases where custody decisions are made or support is ordered. Answer the questions regarding custody and child support. If any of the parties has an order of protection, check the box for who has the order. Check n/a if any of these questions do not apply.
