Instructions:

The disposition form shall be completed and submitted by the attorney filing the initial pleading or other appropriate official as designated by the trial court. This form shall be filed with the court clerk.

1. Complete the docket number and case styling
2. Fill in the name of the juvenile's attorney, and whether the attorney was retained or a public defender.
3. Provide the dates of the adjudication and disposition hearings.
4. Select the trial type. Non-trial types include any type of disposition that does not involve a bench trial or a jury trial.
5. Choose the manner of disposition. Select only one.
6. Choose the outcome of the case, including placement of the juvenile, services or evaluations ordered, and any fees, fines, costs, or sanctions imposed.
7. Indicate whether an interpreter was used for the case. If so, for whom and what language was required?
8. Public Law 104-193 requires collection of certain information in cases where custody decisions are made or support is ordered. Answer the questions regarding custody and child support. If any of the parties has an order of protection, check the box for who has the order. Check n/a if any of these questions do not apply.
9. For a review hearing in reopened cases, complete the information about the review hearing. Indicate whether the juvenile's attorney was present, if the contempt was found, and whether detention was ordered.
