Provided by the federal judiciary, PACER is a public access service that allows users to obtain case and docket information online from federal appellate, district, and bankruptcy courts, and the PACER Case Locator. It is available to anyone who registers for an account and is fee-based. Appellate court staff should contact the Supreme Court Library for assistance; public users may create a personal account.
- **[Pentagon Papers \(HeinOnline\)](#)**. Officially titled *United States - Vietnam Relations, 1945-1967: A Study Prepared by the Department of Defense*, these papers are U. S. Department of Defense history of the political-military of the involvement by the United States in Vietnam from 1945 to 1967.
- **[Revised Statutes of Canada \(HeinOnline\)](#)**. Exact page images of all six revisions from the official printed volumes.
- **[Selden Society Publications & History of Early English Law \(HeinOnline\)](#)**.
