## Supreme Court Swears in New Justices

The Arkansas Supreme Court held formal swearing-in ceremonies for Justice Josephine Linker Hart and Justice Cliff Hoofman in the Supreme Court courtroom of the Justice Building on January 8, 2013.

Surrounded by family, friends, and members of the public, both Justices joined the Court on the bench after taking the oath of office, administered by Chief Justice Jim Hannah. Jonesboro attorney John Belew introduced Justice Hart. Belew praised Justice Hart's work ethic and sense of duty. "This lady will uphold your tradition; she will be at least one seventh, if not more, of this court," he said. Justice Hart responded by promising to "ensure that the rights of the people are not transgressed by the state; a responsibility that rests heavily on this court."

Governor Mike Beebe, who introduced Justice Cliff Hoofman, said that Hoofman was "a model of what's possible in this country." After taking the bench, Justice Hoofman answered by thanking the Governor for the opportunity to serve and vowed that, "for the short time I serve on this court, I will do all that's in my power to seek justice and find fairness for those who have business in this chamber, so help me God."

The ceremony was followed by a reception, hosted by the Supreme Court, where the new Justices had an opportunity to meet with members of the Court, members of the public, family, and friends.



Members of both the Supreme Court and Court of Appeals were honored last month as they prepared to step down from the bench.

From the Supreme Court, Justice Robert Brown and Justice Jim Gunter retired. From the Court of Appeals, Judge John Robbins retired from the bench. Justice Cliff Hoofman and Justice Josephine Hart left the Court of Appeals to fill their new positions on the Supreme Court, previously held by Justices Brown and Gunter. Judge Raymond Abramson and Judge Doug Martin left the Court of Appeals after their appointments ended.

Present at both receptions were members of the Supreme Court and Court of Appeals, their staff, former members of the appellate courts, other Justice Building employees, family, and friends. Departing judges and justices were honored with plaques, awards, photographs, and words of appreciation for their service.

## eFiling Mandatory in Pulaski County Circuit Court

Beginning March 19, 2013, licensed Arkansas attorneys filing new cases or filing to existing cases in the Pulaski County Circuit Courts must submit the filings through eFlex, the electronic filing system. Pulaski County Circuit Courts have been in the eFiling pilot phase since March 2012. Pursuant to the Supreme Court's Administrative Order 21, the one-year grace period will expire and eFiling will become mandatory in Pulaski County Circuit Courts.

In order for attorneys to participate, they must attend one hour of online training, mail a one-time account registration fee of \$100, payable to the "Bar of Arkansas", and request an account online at <http://efile.aoc.arkansas.gov>. A waiver of the electronic filing fee may be requested by individuals who are indigent, disabled, self-represented, and those with special needs.
